Selection will take place by evaluation of the university career, motivations, and research project of the candidate on the proposed research topic (max 60 points) and, for candidates admitted to the second round, an interview (max 40 points).

	The program focuses on the comparisons, connections, and processes of globalization that have characterized different areas of the planet between the 16th and the 20th century and it does so by concentrating on the relational dimension of historical processes, legal regimes, and the organization of power; on the interconnections between economic, political, legal, cultural and social factors; and on circulation, exchange and interconnection of ideas, persons, institutions, legal cultures, political models, concepts, rights and goods on a global scale.
	The areas and themes on which the members of the scientific board can offer international-level training and research preparation are States, wars, ideologies, and violence; History of empires; History of political and social ideas; History of slavery and forced labor; History of migration; Religions and the sacred; Ideas and practices of citizenship; States, nations, languages, peoples, classes, minorities; Cross-cultural relations; Material culture and consumption; History of historiography; The idea of Europe and its history; The legal heritage of Europe and its integration; Comparative law in the historical flux; International institutions; Administrative and private law-making in the global sphere; Human rights; Global legal pluralism; Rule of law and democracy; Public and private powers as actors of global governance; General principles and methods of dispute resolution in the global arena; Comparative federalism.

	Applicants wishing to participate in the selection for this type of fellowship are required to present a research project aimed at reconstructing and interpreting the historical-legal framework of reference, both national and supranational of one or more specific policy areas (by way of example, a few are listed below: migration and political asylum, welfare, citizenship, public goods management, public health, management of pandemic events, etc. etc.) with the aim of providing lawmakers useful tools for the formulation and design of public policies, as well as for reviews of their implementation and the introduction of innovative governance tools. The recipient of the PNRR-PA funded scholarship will develop a project in the outlined areas and carry out a period of study and research of at least six months in an Italian public administration or research center chosen on the basis of the specific policy studied and a period of between 6 and 12 months of research at foreign academic institutions identified on the basis of the research topic.
