Presentazione

L'uso della fame per raggiungere obiettivi politico-militari ci accompagna da sempre. Tuttavia, anche se la carestia irlandese e le pratiche coloniali rappresentano importanti antecedenti, ci sono differenze cruciali tra l'uso fattone nel passato e le straordinarie carestie politiche del XX secolo.

Un semplice elenco, per quanto incompleto, è sufficiente a far capire l'importanza del fenomeno. Carestie causate dalla politica e/o dall'ideologia si sono verificate in tempo di pace in Kazakistan (1931-32, circa 1,5 milioni di vittime); Ucraina (1932-33, circa 3,5 milioni); Cina (1958-62, oltre 25 milioni); e Etiopia (1983-85, circa 0,4 milioni). La fame è stata anche utilizzata in modi nuovi nelle guerre e nei genocidi del XX secolo e il nesso guerra-carestia politica è stato presente nei conflitti successivi alla decolonizzazione, ad esempio nel Biafra. Tutto questo in un secolo in cui il cibo è stato sempre in teoria disponibile e mai sono mancati i mezzi per trasportarlo.

Eppure, a parte qualche rudimentale eccezione, non esistono studi sistematici e comparativi sulle carestie causate da scelte politiche e sull'uso della fame nel XX secolo per far arrendersi un nemico, per "dare una lezione" a un gruppo sociale, nazionale o religioso, o per sottomettere o distruggere un "popolo" o una cultura. Nel suo classico studio del 1981, ad esempio, Sen non ha nemmeno preso in considerazione il fenomeno.

L'argomento richiede quindi uno studio globale, comparativo e transnazionale fondato su un trattamento approfondito delle specifiche carestie politiche. Ciò richiede l'analisi delle loro cause, inclusa l'ideologia, la costruzione dello Stato e le guerre; delle loro conseguenze a breve, medio e lungo termine; dei comportamenti delle vittime e dei responsabili, degli abitanti delle città e delle campagne.

Come la conoscenza delle carestie sovietiche e cinesi ha cambiato in modo sostanziale l'immagine dello stalinismo e del maoismo, un concetto sofisticato di "carestie politiche", eventualmente articolato in diversi sottoinsiemi, potrebbe cambiare in modo significativo la nostra comprensione e percezione del XX secolo, oltre ad aprire nuovi percorsi di ricerca.
